KNOW ALL MEN BY THESE PRESENTS:

THIS CONTRACT made and entered into this 8th day of February, 2023 by and between the Local Government Unit of Lasam, Cagayan, represented herein by the Municipal Mayor DANTE DEXTER A. AGATEP as LGU Lasam.
(Hereinafter called the owner)

PARTY OF THE FIRST PART and HHK CONSTRUCTION
(Hereinafter called contractor)

represented by MS. YVONNE KATHRINA S. FLORIDA as PARTY OF THE SECOND PART.

WHEREAS, the owner is desirous that certain works should be supplied and delivered, namely: CONCRETING OF FARM TO MARKET ROAD @ NABANNAGAN WEST-TUCALAN PASSING, LASAM, CAGAYAN has accepted the bid by the Contractor for the supply and completion of such works, for the amount of FORTEEN MILLION SEVEN HUNDRED THIRTY THREE THOUSAND SIX HUNDRED TWENTY SIX PESOS AND SIXTY FIVE CENTAVOS.(P 14,733,626.65)

The whole works comprised in the contract shall be completed within 144 calendar days, in accordance with the provisions of the Bid Documents.

The contractor, at his own proper cost expenses shall fully and faithfully perform all work, furnish all the materials, equipment and labor necessary for the supply and delivery consisting of the following items of work involved:
