WHEREAS, the owner is desirous that certain works should be supplied and delivered , namely: CONCRETING OF FARM TO MARKET ROAD @ TUCALAN PASSING, LASAM, CAGAYAN has accepted the bid by the Contractor for the supply and completion of such works, for the amount of Four Million Nine Hundred Ninety Seven Thousand Four Hundred Thirteen Pesos and Forty Centavos (4,997,413.40).



7. This agreement becomes valid and binding upon approval in accordance with the provisions of PD No. 1594.




