KNOW ALL MEN BY THESE PRESENTS:

THIS CONTRACT made and entered into this 20th day of February, 2024 by and between the Local Government Unit of Lasam, Cagayan, represented herein by the Municipal Mayor DANTE DEXTER A. AGATEP as LGU Lasam (hereinafter called the owner)

PARTY OF THE FIRST PART and JO-LEA TRADING ENTERPRISES (hereinafter called contractor)

represented by LEA B. GALAO as PARTY OF THE SECOND PART.

WHEREAS, the owner is desirous that certain works should be supplied and delivered , namely: PURCHASE OF VARIOUS MEDICAL SUPPLIES FOR 1ST QUARTER C.Y. 2024 has accepted the bid by the Bidder/Supplier for the supply and completion of such works, for the amount of Three Hundred Sixty One Thousand Three Hundred Fifty Three Pesos and One Centavo: (P 361,353.01).

5. The contractor warrants that he has not given nor promised to give money or gift to any employee of the Owner to secure this contract.
