THIS CONTRACT made and entered into this 18th day of June, 2024 by and between the Local Government Unit of Lasam, Cagayan, represented herein by the Municipal Mayor DANTE DEXTER A. AGATEP as LGU Lasam.

PARTY OF THE FIRST PART and HHK CONSTRUCTION

(Hereinafter called contractor)

represented by YVONNE KATHRINA S. FLORIDA as PARTY OF THE SECOND PART.

WHEREAS, the owner is desirous that certain works should be supplied and delivered, namely: <u>REBLOCKING OF ROAD @ CENTRO 02</u>, <u>LASAM</u>, <u>CAGAYAN</u> has accepted the bid by the Contractor for the supply and completion of such works, for the amount of <u>Two Million Four Hundred Ninety-Eight Thousand Three Hundred Ninety-One Pesos and Fifty-Eight Centavos (PHP 2,498,391.58).</u>

- 3. The Owner hereby covenants to pay the contractor in consideration of the Supply, deliver and completion of the works, the contract price at the times and in all manner prescribed by the contract and specified in the Bid.
- 4. The implementing Rules and Guidelines regarding adjustment of Contract Price adopted and approved by the government will be applied in this contract.
- 5. The contractor warrants that he has not given nor promised to give money or gift to any employee of the Owner to secure this contract.
- 6. That the contractor shall comply with, and strictly observed, all laws regarding workmen's health and safety, workmen's welfare, compensation for injuries, minimum wages, hours of labor and other labor laws.
- 7. This agreement becomes valid and binding upon approval in accordance with the provisions of PD No. 1594.
