KNOW ALL MEN BY THESE PRESENTS:

THIS CONTRACT made and entered into this 18th day of June, 2024 by and between the Local Government Unit of Lasam, Cagayan, represented herein by the Municipal Mayor DANTE DEXTER A. AGATEP as LGU Lasam,
(hereinafter called the owner)

PARTY OF THE FIRST PART and KSERVICO TRADE, INC.
(hereinafter called contractor)

represented by JOANNA MARIE A. SOMERA as PARTY OF THE SECOND PART.

WHEREAS, the owner is desirous that certain works should be supplied and delivered, namely: Purchase of 12 Units Three-Wheeled Patrol Car for Barangay DRRMCs has accepted the bid by the Bidder/Supplier for the supply and completion of such works, for the amount of Three Million Eight Hundred Ninety Nine Thousand Three Hundred Sixty Five Pesos and Ninety Two Centavos (Php. 3,899,365.92).

The whole works comprised in the contract shall be completed within 30 calendar days, in accordance with the provisions of the Bid Documents.

5. The contractor warrants that he has not given nor promised to give money or gift to any employee of the Owner to secure this contract.
