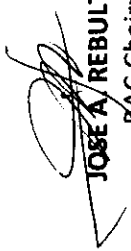

THIS CONTRACT made and entered into this 24th day of June, 2024 by and between the Local Government Unit of Lasam, Cagayan, represented herein by the Municipal Mayor **DANTE DEXTER A. AGATEP** as LGU Lasam,
(hereinafter called the owner)

PARTY OF THE FIRST PART and JO-LEA TRADING ENTERPRISES
(hereinafter called contractor)

represented by **LEA B. GALAO** as PARTY OF THE SECOND PART.

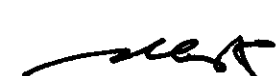
THIS AGREEMENT WITNESSETH AS FOLLOWS:

5. The contractor warrants that he has not given nor promised to give money or gift to any employee of the Owner to secure this contract.

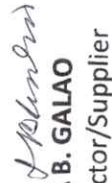
