KNOW ALL MEN BY THESE PRESENTS:

THIS CONTRACT made and entered into this 17th day of July, 2025 by and between the Local Government Unit of Lasam, Cagayan, represented herein by the Municipal Mayor DANTE DEXTER A. AGATEP as LGU Lasam, (hereinafter called the owner)
PARTY OF THE FIRST PART and TOYOTA TUGUEGARAO CITY (hereinafter called contractor) represented by ROXANNE L. CORPUZ as PARTY OF THE SECOND PART.

WHEREAS, the owner is desirous that certain items should be supplied and delivered, namely: Purchase of 1 Unit Brand New Commuter Van for PESO Use has accepted the bid by the Bidder/Supplier for the supply and completion of such works, for the amount of ONE MILLION NINE HUNDRED NINETY SIX THOUSAND EIGHT HUNDRED FORTY TWO PESOS (1,996,842.00).

The whole works comprised in the contract shall be completed within 60 calendar days, in accordance with the provisions of the Bid Documents.

The contractor, at his own proper cost expenses shall fully and faithfully perform all work, furnish all the materials, equipment and labor necessary for the supply and delivery consisting of the item involved:

2. In consideration of the payment to be made by the Owner to the contractor are hereinafter mentioned, the contractors hereby covenants with the Owner to Supply, deliver and complete the work in conformity in all respects with the provisions of the contract.
3. The Owner hereby covenants to pay the contractor in consideration of the Supply, deliver and completion of the items, the contract price at the times and in all manner prescribed by the contract and specified in the Bid.
4. The implementing Rules and Guidelines regarding adjustment of Contract Price adopted and approved by the government will be applied in this contract.
5. The contractor warrants that he has not given nor promised to give money or gift to any employee of the Owner to secure this contract.
