KNOW ALL MEN BY THESE PRESENTS:

THIS CONTRACT made and entered into this 13<sup>th</sup> day of August, 2025 by and between the Local Government Unit of Lasam, Cagayan, represented herein by the Municipal Mayor DANTE DEXTER A. AGATEP as LGU Lasam,  
*(hereinafter called the owner)*

PARTY OF THE FIRST PART and POWERTRAC INCORPORATED  
*(hereinafter called contractor)*

represented by EDWIN M. LOPEZ as PARTY OF THE SECOND PART.

WHEREAS, the owner is desirous that certain items should be supplied and delivered, namely: Purchase of 1 Unit Brand New Self-loading Truck 22 Tons with 5 Tons Boom 380 HP 10W Euro 2 has accepted the bid by the Bidder/Supplier for the supply and completion of such works, for the amount of FIVE MILLION NINE HUNDRED EIGHTY THOUSAND PESOS (5,980,000.00).
