KNOW ALL MEN BY THESE PRESENTS:

THIS CONTRACT made and entered into this 18th day of September, 2025 by and between the Local Government Unit of Lasam, Cagayan, represented herein by the Municipal Mayor **DANTE DEXTER A. AGATEP** as LGU Lasam,
(hereinafter called the owner)

PARTY OF THE FIRST PART and ALEJANDRA ENTERPRISES
(hereinafter called contractor)

represented by **CECILIA ANGELA MEDINA RAMIREZ** as PARTY OF THE SECOND PART.

WHEREAS, the owner is desirous that certain works should be supplied and delivered, namely: Purchase of Sleeping Kits for Municipal Evacuation Center 2 has accepted the bid by the Bidder/Supplier for the supply and completion of such works, for the amount of Three Hundred Fourteen Thousand Nine Hundred Eighty One Pesos (314,981.00).


THIS AGREEMENT WITNESSETH AS FOLLOWS:
