

## KNOW ALL MEN BY THESE PRESENTS:

THIS CONTRACT made and entered into this 24<sup>th</sup> day of October, 2025 by and between the Local Government Unit of Lasam, Cagayan, represented herein by the Municipal Mayor **DANTE DEXTER A. AGATEP** as LGU Lasam,  
(hereinafter called the owner)

PARTY OF THE FIRST PART and TOYOTA TUGUEGARAO CITY,  
(hereinafter called contractor)

represented by **ROXANNE L. CORPUZ** as PARTY OF THE SECOND PART.
