## KNOW ALL MEN BY THESE PRESENTS:

THIS CONTRACT made and entered into this 10<sup>th</sup> day of March, 2025 by and between the Local Government Unit of Lasam, Cagayan, represented herein by the Municipal Mayor DANTE DEXTER A. AGATEP JR. as LGU Lasam.

PARTY OF THE FIRST PART and DECA CONSTRUCTION  
*(Hereinafter called the owner)*

represented by ARISTOTLE P. DUPAYA as PARTY OF THE SECOND PART.

WHEREAS, the owner is desirous that certain works should be supplied and delivered, namely: REHABILITATION OF FARM TO MARKET ROAD @ ZONE-03 MALINTA, LASAM, CAGAYAN has accepted the bid by the Contractor for the supply and completion of such works, for the amount of Nine Hundred Ninety Seven Thousand Four Hundred Seventy Four Pesos and Thirty Two Centavos Only (PHP 997,474.32).

The whole works comprised in the contract shall be completed within 50 calendar days, in accordance with the provisions of the Bid Documents.

The contractor, at his own proper cost expenses shall fully and faithfully perform all work, furnish all the materials, equipment and labor necessary for the supply and delivery consisting of the following items of work involved:

4. The implementing Rules and Guidelines regarding adjustment of Contract Price adopted and approved by the government will be applied in this contract.
5. The contractor warrants that he has not given nor promised to give money or gift to any employee of the Owner to secure this contract.
6. That the contractor shall comply with, and strictly observed, all laws regarding workmen's health and safety, workmen's welfare, compensation for injuries, minimum wages, hours of labor and other labor laws.
7. This agreement becomes valid and binding upon approval in accordance with the provisions of PD No. 1594.
