KNOW ALL MEN BY THESE PRESENTS:

THIS CONTRACT made and entered into this 3rd day of September, 2025 by and between the Local Government Unit of Lasam, Cagayan, represented herein by the Municipal Mayor DANTE DEXTER A. AGATEP JR. as **LGU Lasam.**
(Hereinafter called the owner)

PARTY OF THE FIRST PART and **C.J.T. PASCUAL CONSTRUCTION**
(Hereinafter called contractor)


represented by CHARESMA JOY T. PASCUAL as PARTY OF THE SECOND PART.

WHEREAS, the owner is desirous that certain works should be supplied and delivered, namely: **CONCRETING OF ACCESS ROAD LEADING TO SANITARY LANDFILL WITH SLOPE PROTECTION @ MINANGA NORTE, LASAM, CAGAYAN** has accepted the bid by the Contractor for the supply and completion of such works, for the amount of **One Million Nine Hundred Ninety Seven Thousand Fifty Pesos and Forty Four Centavos Only (PHP 1,997,050.44)**.

 - n. Cash Flow Projection and Quarterly Basis

2. In consideration of the payment to be made by the Owner to the contractor are hereinafter mentioned, the contractors hereby covenants with the Owner to Supply, deliver and complete the work in conformity in all respects with the provisions of the contract.

5. The contractor warrants that he has not given nor promised to give money or gift to any employee of the Owner to secure this contract.
6. That the contractor shall comply with, and strictly observed, all laws regarding workmen's health and safety, workmen's welfare, compensation for injuries, minimum wages, hours of labor and other labor laws.
7. This agreement becomes valid and binding upon approval in accordance with the provisions of PD No. 1594.
