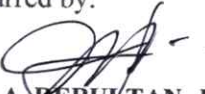
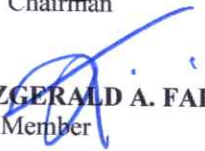
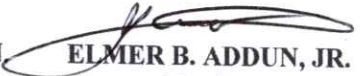
NOW, THEREFORE, We, the Members of the Bids an Awards Committee, hereby RESOLVED, as it is hereby RESOLVED:
