KNOW ALL MEN BY THESE PRESENTS:

THIS CONTRACT made and entered into this 12th day of December, 2025 by and between the Local Government Unit of Lasam, Cagayan, represented herein by the Municipal Mayor DANTE DEXTER A. AGATEP JR. as

LGU Lasam.

(Hereinafter called the owner)

PARTY OF THE FIRST PART and **DECA CONSTRUCTION**

(Hereinafter called contractor)

represented by ARISTOTLE P. DUPAYA as PARTY OF THE SECOND PART.

WHEREAS, the owner is desirous that certain works should be supplied and delivered, namely: **CONSTRUCTION OF YOUTH LEARNING CENTER @ CENTRO 02, LASAM, CAGAYAN** has accepted the bid by the Contractor for the supply and completion of such works, for the amount of **Two Million Nine Hundred Ninety Seven Thousand Eight Hundred Ninety Three Pesos and Ninety Two Centavos Only (PHP 2,997,893.92).**

6. That the contractor shall comply with, and strictly observed, all laws regarding workmen's health and safety, workmen's welfare, compensation for injuries, minimum wages, hours of labor and other labor laws.
7. This agreement becomes valid and binding upon approval in accordance with the provisions of PD No. 1594.



That the provision of Republic Act No. 6685 and DPWH Ministry Order No. 17-A are incorporated in this Agreement.
