WHEREAS: two (2) sets of bid proposals were submitted on February 18, 2026 but the bid of DECA Construction passed the preliminary examination of bids wherein there was a document of Flavie Civil Engineering Construction that needs further evaluation. Further, financial proposals appear below;

NOW, THEREFORE, We, the Members of the Bids an Awards Committee, hereby RESOLVED, as it is hereby RESOLVED:


